1. OPENING

A. Roll Call

A. 2045 Metropolitan Transportation Plan (MTP)/Long Range Transportation Plan (LRTP) Consultant Selection Process

D. FAST Act Safety Performance Measures and Targets.

He explained the process of developing the measures and targets, as well as the Federal requirements to adopt these procedures.
