#### 1. OPENING

#### A. Roll Call

#### 2. OLD BUSINESS

#### A. Nominations and Election of TAC Chair and Vice Chair

Mr. Council stated the 2-year period for nominating Chair and Vice Chair was in January of the even numbered year.

- Ms. Mary Bass-Fontenot motion for Mike Daigle a Chair, seconded by Mr. John Cardone. Motion carried unopposed.
- Ms. Fontenot motioned for John Cardone as Vice Chair, seconded by Mr. Cardone. Motion carried unopposed.

## B. New Transportation Improvement Program (TIP) FFY 2019-22

Mr. Council, via Powerpoint, presented the steps and tasks needed to amend and program projects into the upcoming TIP FFY 2019 -22 that would utilize STP<200K funding.

- Mr. Cardone asked about Ihles and Prien Lake Road project, why it did not appear as one of the 7 remaining projects. Mr. Council's response was that it was selected during the 2016 Project Call, but not moved into Stage 1 of the 2040 MTP. However, all projects can be amended and moved up to the priority list, if recommended by TAC and approved by TPC.
- Mayor Nic Hunter and Mr. Cardone requested an additional column for actual cost of the seven projects.
- Mr. Wesley Crain suggested a flow chart to visually explain each of the steps needed to move the projects through the process (selection from Stage 1 of 2040 MTP; Stage 0 process, final programming into TIP FY 2019-22.
- Ms. Fontenot motioned to recommend tabling discussion, seconded by Mr. Cardone.
- Mayor Duncan motioned to table discussion, seconded by Mayor Hunter.

# C. 2045 Metropolitan Transportation Plan (MTP)/Long Range Transportation Plan (LRTP) Development



Ms. Soileau stated that Stantec, on 1/23/18 at the SEED Center, facilitated an interactive steering committee meeting for development of the 2045 MTP development, to guide the project schedule.

## D. I-210 Bridge Regional Traffic Study Update

Ms. Soileau noted that I-210 Regional Traffic Study Public Open House 30, 2018, 10 am – 1 pm.

- Ms. Soileau encouraged people to modify their travel patterns.
- Mr. Don Duberville suggested noted there would be a tentative I-210 bridge re-decking let in May 2018.
- Mayo Hunter and Ms. Soileau recommend the MPO craft their own message, so they can speak directly to the people. Maybe conduct a 3minute video with elected officials explaining when things will begin.
- Mr. Crain advised using Calcasieu Parish's C-GOV cable channel.
- Mr. Cardone suggested making sure LaDOTD is part of the dialogue.
- Ms. Fontenot added the message should be short and sweet.

## E. Complete Streets: Better Block Sulphur, LA

Mr. Council informed that inclement weather cancelled the Sulphur Better Block, 2/3/18.

 Mayor Duncan explained that a new date is being prepared for April 7, 2018.

#### 3. NEW BUSINESS

## A. Performance Measure: Transportation for America (T4America) Workshop

Ms. Soileau shared that seven local stakeholders attended workshop in Baton Rouge, 1/25/18 - 1/26/18 on performance measure integration into project ranking process.

- Mr. Mike Daigle, an attendee, noted new ways to rank projects, and discussion on environmental health.
- Ms. Soileau reiterated that the goal was to generate well rounded projects that pop up on every level.
- · A report on final feedback will be incoming.

## B. I-10 Calcasieu River Bridge Joint Repair Project

Mr. Council shared pertinent aspects of the joint repair project on I-10 Calcasieu River Bridge.

- Work scheduled from March 3 June 30, 2018 (4 months)
- Construction teams working 24-7 shifts



- Eastbound will first be reduced to one lane for 2 months, then westbound limited to one lane for 2 months.
- Motorist Assistance Patrol (MAP) units will have 3 trucks available in the day time and 2 at night.
- 511 system (<a href="http://www.511la.org">http://www.511la.org</a>); LaDOTD Twitter (<a href="http://wwwsp.dotd.la.gov/Pages/default.aspx">http://wwwsp.dotd.la.gov/Pages/default.aspx</a>); Local radio and TV will also advise on road conditions and/or detours.
- Large freight trucks advised not to take I-1- bridge during 4-month period.

## C. Amendment XVI for the TIP

Staff is requested TAC recommendation for TPC final approval, Amendment XVI. Calcasieu Parish Transit seeking 12-passenger gas powered buses and 10 baby car seats, using STPFlex funds (\$192.6 Total/154.1 Fed Share). The 14-day Public Review/Hearing period was initiated by staff on 2/15/18.

- Mayor Chris Duncan motioned, seconded by Mayor Nic Hunter.
- D. Advance Program: Southwest Louisiana Air Quality Task Force

Ms. Soileau and Mr. Council shared that the All Hazards Transportation Recovery Plan will be held March 19 - 20, 2018, from 9 am - 4:30 pm.
