During a special meeting of the Lake Charles Metropolitan Planning Organization Technical Committee held Wednesday, April 14, 2021, members unanimously voted the following:

The Lake Charles Metropolitan Planning Organization Technical Advisory Committee recommends "Alternate 5G" to the MPO Transportation Policy Committee with the following additional two qualifications:

1. That a collaboration between Kansas City Southern Railroad, Louisiana Department of Transportation and Development (DOTD), and City of Westlake Mayor Bob Hardey has a satisfactory outcome to allow for the Westlake Riverfront Development Project; and
2. That the "Alternate 5G" bridge design incorporate iconic features, including but not limited to a cable stayed effect, LED signature lighting and traditional cross pistols.
