2. OLD BUSINESS

A. Transportation Improvement Program (TIP) FY 2023 - 26 – Walter Council

No action requested.

Administrative Modifications.

Increased L.000062 Motorist Assistance Program for FY 2023-26, from \$412K/year to \$467K/year for 4 years. The funding source name changed from STP50-200K to Carbon Reduction.

B. Transportation Improvement Program (TIP) FY 2023 - 26 - Walter Council

No action requested.

Administrative Modifications.

H.013870 Enterprise Blvd (Broad St to 12th St) has overage, which is already authorized and needs no amendment.

- Original Total Cost (w/ 10% contingency): In FY 22 is \$7,480,000 using STP50-200K.
- New Total Cost (w/ 10% contingency): \$9,496,564.
- Difference/Overage: In FY 23 is \$2,377,437 (80% Fed Share of \$1,901,950; 20% Local Match of \$475,487)
 - ➤ The City of Lake Charles has agreed to the \$475,487 local match in FY 23.

C. Transportation Improvement Program (TIP) FY 2023 - 26 – Walter Council

H.014370 Post Oak Rd (Burton St to Aubrianna Ln) has overage, which is already authorized and needs no amendment.

- Original Total Cost (w/ 10% contingency): In FY 22 is \$3,410,000 using STP50-200K.
- New Total Cost (w/ 10% contingency): \$4,143,343
- Difference/Overage: In FY 23 is \$733,343 (80% Fed Share of \$586,674; 20% Local Match of \$146,668)
 - The City of Sulphur has agreed to the \$146,668 local match in FY 23.

D. Amending the Transportation Improvement Program (TIP) FY 2023-26 Amendment 2 (Aggregate Record Item No. 5) - Walter Council Action requested.

Action requested on TAC recommendation (1/25/23), to TPC, to adjust funding and programming years for Calcasieu Parish Overlays from FY 23 into FY 24 and FY 25.

 - \$819,962 total (includes 10% contingency; \$655,970 Fed Share; \$163,992 Local Match)

Added LA 1256 @ W. Cal Rd (R/W) using STP50-200K. H.***** in FY 26:

• \$3M total (includes 10% contingency; \$2.4M Fed Share; \$600K Local Match)

G. Multimodal/Complete Streets/Design Integration Corridor Plan – Mike Hollier Action requested.

Action requested on TAC recommendation (1/25/23), to TPC, to form multimodal Complete Streets sub-committee to review and advance design standards for all 2050 MTP roadway projects with preliminary recommendations sent to the TAC.

H. Urban (MPO) Traffic Management Center Feasibility Study – Steve Jiles Action requested.

Action requested on TAC recommendation (1/25/23), to TPC, to form a Traffic Management Center by advancing a \$60,000 feasibility study contract.

3. NEW BUSINESS

A. Amending the 2045 Metropolitan Transportation Plan and TIP FY 2023-26 Safety Performance Measures

Amendment 1 (Aggregate Record Item No. 4) - Walter Council Action requested.

Action requested on TAC recommendation (1/25/23), to TPC, to adopt LaDOTD's FY 23 Safety Performance measures and targets in TIP FY 2023 – 26:

- 1 % reduction in fatalities from a 2021 baseline of 814 to a target of 797 in 2023.
- 1 % reduction in serious injuries from a 2021 baseline of 1,425 to a target of 1,396 in 2023.
- 1 % reduction in fatality rate from a 2021 baseline of 1.601 to a target of 1.568 in 2023.
- 1 % reduction in serious injury rate from a 2021 baseline of 2.804 to a target of 2.748 in 2023.
- 1 % reduction in non-motorized fatalities and serious injuries from a 2021 baseline of 398 to a target of 390 in 2023.

B. Resolution 2023-01 Amending the Transportation Improvement Program (TIP) FY 2019-22 Amendment 37 (Aggregate Record Item No. 72) - Walter Council Action requested.

Action requested on TAC recommendation (1/25/23), to TPC, to add 2 Calcasieu Parish Transit Operating Assistance grant projects in FY 22, one as Section 5310 for \$570,000 (100% Fed Share) and another as Section 5316 for \$190,000 (100% Fed Share), plus adding Calcasieu Parish Calcasieu Council on Aging's Section 5310 Capital Assistance grant project for \$136,347 (85% Fed Share for \$115.8K; 15% Local Match for \$19.8K) in FY 22.

C. 2050 Metropolitan Transportation Plan (MTP) Preparation – Mike Hollier Action requested.

Action requested on TAC recommendation (1/25/23), to TPC, for preparation of 2050 MTP including LaDOTD approval for Scope of Work.

D. Joint 3 MPO Electric Vehicle Charging Station Interstate Grant Application – Mike Hollier Action requested.

Action requested on TAC recommendation (1/25/23), to TPC, to form mutual western Louisiana MPO electric vehicle charging station collaborative.

4. INFORMATION

A. Chennault Area Traffic Study (C.A.T.S) – Mike Hollier Information only. No action required.

Preparation has initiated for C.A.T.S., using STP50-200K funds in TIP FY 2023 – 26 in FY 23. City of Lake Charles, Calcasieu Parish, and LaDOTD have preliminarily agreed to jointly fund the local match.

- \$350,000 (\$280,000 Fed Share; \$70,000 Local Match).
- **B. IMCAL MPO Planning Services** Mike Hollier Information only. No action required.

Preparation has initiated for new IMCAL MPO Planning Services supplemental contract, using STP50-200 funds in TIP FY 2023 – 26 in FY 23.

- \$350,000 (\$280,000 Fed Share; \$70,000 Local Match)
- C. Annual List of Obligated Projects (ALOP) Unified Planning Work Program (UPWP) FY 2022-23 Walter Council

Staff completed ALOP, documenting federal funding obligations for roadway, bike/ped, and transit investments in the Lake Charles Metropolitan Planning Area in FY 22:

- Roadways (\$39.2M Fed Share; \$8.4M Local Match)
- Transit (\$2.7M Fed Share; \$1.1M Local Match)
