Preparation of the Lake Charles Louisiana Metropolitan Planning Organization (MPO) 2050 Transportation Plan in conformance with the latest U.S. Code of Federal Regulations. Title 23, Chapter 1, Subchapter E. Sections 450.306 and 450.324.

Work Tasks

- 1. Administration of Work Scope
 - a. Personnel
 - b. Travel/Transportation
 - c. Materials and Supplies
- 2. Project Schedule, Work Plan and Committee Activity
 - a. Outline all work and deliverables
 - b. Compose a schedule for delivery of all products and services.

 - b. Implement public involvement plan.
 - c. Document data and input collected. Identify trends and themes.
