The TAC recommended (7/7/21 meeting) for TPC to adopt amending TP FY 2019 -22 to motione remover feasibility phase for Project No. H.012043 LA 378: Calcasieu R MB RH (WEST FORK) (HBI) at \$150K of STPFLEX in FY 2021. Added engineering phase of \$150K of STPFLEX at 80% Fed Share in FY 21.

- ➤ Scope of work for H.012043: Full structural, mechanical, electrical, and architectural rehabilitation of an Historic Bridge Inventory (HBI) movable bridge structure. Work to include the application of new protective coating (paint) systems, and renovations to the Operator's House.
